We support passage of the Homeopathic Drug Product Safety, Quality and Transparency Act as the best solution for long-term protection of access to the full range of homeopathic medicines and for addressing the unique nature of homeopathic medicines and the specific conditions and requirements related to their manufacture, labeling, promotion, distribution, and use.
